Admissions Policy and Procedures

The Safeguarding and Welfare Requirements

Norfolk House Nursery endeavour to have an inclusive and fair admissions policy, and have a clear order of priority of offering places.

General

- Children can join the nursery from the age of three months up to four years old.
- The nursery is open to the community and does not discriminate against any child who has a disability or on the basis of ethnicity, religion or social background, there will be equality of access to nursery places.
- Transition to Norfolk House School is not guaranteed and parents who wish their child to progress to the school should contact the school at the earliest opportunity.

Registration

We have a robust Registration Procedure in place- *see Norfolk House Nursery Registration Procedure*

Places are subject to availability.

Places are offered on a first come first served basis, however where required priority will be given in the following order:

- Children of families with exceptional circumstances/special needs. Supporting evidence will be required and an assessment may have to be undertaken to ensure we are able to cater for the child's

Internal Waiting List

We operate both an internal and external waiting list, which is reviewed weekly by the Nursery Manager. When a place becomes available, and an application to join the waiting list has been completed, the family should be contacted and offered the place. If they accept, the procedure set out in paragraphs 4 to 5 of Norfolk House Nursery Registration Procedure should be adhered to.

Early Education Entitlement (EEE)

Two year olds

- Some two year olds are eligible for 570 hours per year subject to certain criteria.
- A child's entitlement begins at the start of the term following their second birthday.
- Funded only space is limited and subject to availability for 2 year only funding (15 hours) only. The offer of funded hours only is at the Nursery Managers discretion and is prioritised to children who have been referred by outside agencies such as a Health Visitor.
- The entitlement offers 570 hours (15 hours per week) a year over no fewer than 38 weeks and up to 52 weeks of the year. The entitlement is for regular attendance agreed between the parent and Norfolk House Nursery.

Three and four year olds

- The Government provides Universal Funding for all three and four year old children to attend an Ofsted registered early year's provider. This is known as the Early Education Entitlement (formally the Nursery Education Grant).
- A child's entitlement begins at the start of the term after their third birthday and lasts until they reach statutory school age (the term after their fifth birthday).
- The entitlement offers 570 hours (15 hours per week) a year over no fewer than 38 weeks and up to 52 weeks of the year. The entitlement is for regular attendance agreed between the parent and Norfolk House Nursery.
- In addition to this some families may be entitled to Extended Entitlement. The entitlement offers an additional 570 hours (15 hours per week) a year over no fewer than 38 weeks and up to 52 weeks of

the year.

- Norfolk House Nursery offers both Universal (15 hours) and Extended Entitlement (30 hours) which is stretched across 52 weeks.
- Funded only space is limited and subject to availability for Universal Entitlement for three and four year olds (15 hours) only. The offer of funded hours only is at the Nursery Managers discretion and is prioritised to children who have been in receipt of 2 year old funding or who have been referred by outside agencies such as a Health Visitor.

Funded spaces are limited to one space per afternoon session:

Monday:	1.00pm-4.00pm (3 hours)
Tuesday:	1.00pm-4.00pm (3 hours)
Wednesday:	1.00pm-4.00pm (3 hours)
Thursday:	1.00pm-4.00pm (3 hours)
Friday:	1.00pm-4.00pm (3 hours)
Total:	15 hours
